The individual must be:

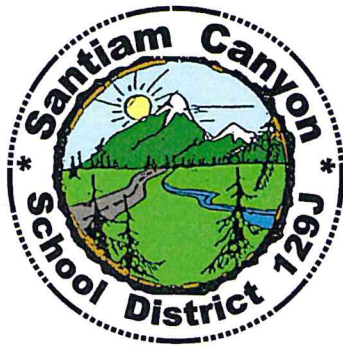
- a) An elector of the district (qualified to vote under Section 2, Article II of the Oregon Constitution)
