There will be no refund for students who quit the team, who are removed for disciplinary reasons or for students who do not maintain the required academic eligibility.

To qualify to work off fees, student must qualify for free/reduced lunch and submit a letter stating why they should be considered for work off status. Only 12 students (MS – 6 / HS – 6) per-season will be considered for the work off program.
